



SUBJ: **RETIREMENT OF GINGER FRANK**

Wilma "Ginger" Frank, SAM's Chemist, retired on June 1, 2000. Ginger began her career at SAM June 27, 1984 and was in charge of the Authority's laboratory from August 1986 until her retirement. Over those years, she has done an excellent job of providing SAM with the reliable analytical data we need to run our treatment plant and comply with our discharge permit. Some of her many contributions include:

- Continually meeting the State of California's rigorous requirements for laboratory certification.
- Designing and carrying out a bacterial assessment study which demonstrated to the Regional Water Quality Control Board that local creeks, rather than SAM's treated discharge, are the cause of elevated bacterial counts on beaches.
- Training operations personnel in laboratory procedures, allowing us to achieve a significant improvement in overall staffing efficiency.
- Working with our architect on a comprehensive laboratory redesign that was central to our administration building remodeling project.

Ginger's retirement promises to be every bit as busy as her work life here. She recently completed a holistic health services certification program at San Francisco State University. She has moved to the house she built at Clear Lake and is already active in community affairs and health services there. Since she still owns a home in El Granada, she'll continue to be a frequent visitor to the coastside.

The entire SAM staff expresses its appreciation to Ginger and wishes her well. We would like the Board to consider the attached resolution commending Ginger for her service to SAM.
